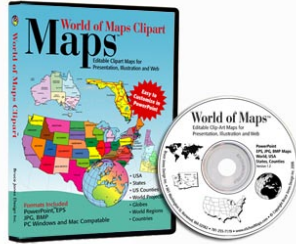

3. Competing with Bruce Jones Design Inc. and the World of Maps clip art collection.

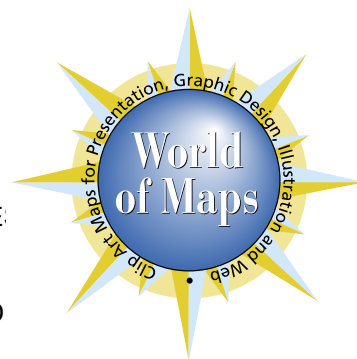
Termination
